



## Privacy Policy

### **RIGHTS OF THE USER IN RELATION TO THEIR PERSONAL DATA**

The request must contain the name, surname of the INTERESTED PARTY, copy of a document that proves your identity (such as passport or identity card) and, in the cases that are admitted, identification document of the person who represents them, as well as a document proving the representation, a document in which the petition is specified, address for the purposes of notifications, date and signature of the applicant and supporting documents of the petition he formulates.
